### Molly's Miles 2018

April 7, A very chilly April morning saw Molly's Miles amazing team members and runners gather for a very successful albeit cold morning.

Molly is Molly Thomas-Bowden as most of you know she was an officer with the Columbia, MO PD. She was shot during a routine traffic stop on Monday, January 10, 2005. Molly succumbed to her injuries on February 10, 2005.

The event, honors all officers killed in the line of duty and benefits their families and coworkers.

Buddy and Christine Anliker, avid runners themselves, started Molly's Miles after the 2016 shootings of Dallas police officers. Buddy Anliker worked with the run's namesake, Molly Bowden, at the MU Police Department and was devastated when the Columbia PD lost her in 2005.

"This run is in memory of our own fallen officer," according to Civilian Public Information officer Bryana Larimer, she said, "It's important to keep her memory alive in this community."

Larimer said last year's run attracted over 900 participants. UltraMax had told them to expect between 200 and 300 runners. Despite sub-freezing temperatures Saturday morning, more than 1,000



runners arrived at the Molly Bowden Memorial Park for the second annual Molly's Miles 5K and 10K races.

The memorial run raised over \$32,000 for the Missouri Chapter of Concerns of Police Survivors.

## Traumas In Law Enforcement Training

August 2018

Concerns of Police Survivors (C.O.P.S.) provides training to America's law enforcement agencies on how to appropriately respond to officers and their families affected by line-of-duty traumas through the "Traumas of Law Enforcement" trainings.

The Training this August was hosted in Camdenton, by National C.O.P.S. The new training room rose to the challenge of a packed house of participants.

At these trainings, instructors presented information that is important to America's law enforcement agencies regarding appropriate response to line-of-duty death, disability, critical incidents, and police suicide.

The training was presented over three days and includes 21-hours of class time. Annette, Jansen, Stacy Taylor-Brakhage, and Cody Biggs from Missouri Chapter, participated in a panel discussing their experiences.

## Missouri Memorial Service

May 5, 2018, Two Missouri police officers and two sheriff's deputies who died in the line of duty between 1917 and 2017 were honored May 5th during Missouri's annual Law Enforcement Memorial Service for those who have paid the ultimate price for their service protecting their fellow Missourians.

Officers, their families and friends from across the state gathered at the Carnahan Memorial Garden, near the site of Missouri's Law Enforcement Memorial, where the names of Barry County Sheriff's Office Master Sergeant Deputy Carl T. Cosper and Clinton Police Officer Gary L. Michael, Jr. both of whom died in 2017, were added to the memorial's Wall of Honor. Also honored on the wall were Village of Miramigoua Police Officer Kevin M. Dziejma, who died of a heart attack during a traffic stop in 2015, and Platte County Sheriff's Office Deputy Edward E. Culver, who was shot and killed after responding to an altercation in 1917.


Gov. Eric Greitens was the guest speaker at the memorial service.

"Each day, a select, brave few Missourians put on body armor, leave their homes, and risk their lives to protect their fellow citizens and make our streets safer," Gov. Eric Greitens said. "Today, we honor those who never made it home; those who courageously and selflessly made the ultimate sacrifice in service to others. We will never forget the examples they set or the families they left behind."

"There is no nobler career than law enforcement, and the heroes we honor today were the best among us," Department of Public Safety Director Drew Juden said. "We will always remember the lives they lived, the values they died protecting. We stand with and support their survivors, who will always remain part of our Missouri law enforcement family."

Each year, the families of law enforcement officers who have died in the line of duty in the previous year, and through the decades, participate in the ceremony by placing white carnations in a wreath in honor for Missouri's fallen heroes.


### Grand Opening National



## National Police Week

May 11-17, 2018,

National Police Week  
Washington D.C. – 2018

May 11 - May 17

Each year our nation loses between 140-160 law enforcement officers in the line of duty. National Police Week (NPW) held May 11 – 17 each year in Washington, D.C. honors the service and sacrifice of U.S. law enforcement officers. On May 11 and 12, surviving families and co-workers begin arriving in Washington, D.C. for the week-long events.

The first major event is the Candlelight Vigil hosted by the National Law Enforcement Officers Memorial Fund (NLEOMF) on May 13. The service began at 8:00 p.m. with the newly engraved names

Concerns of Police Survivors (C.O.P.S.) hosts the National Police Survivors' Conference on May 14 and May 16 at the Hilton Alexandria Mark Center, the host hotel.

The conference includes breakfast, lunch, guest speakers, debriefing sessions and a Kids/Teens program for the surviving children and siblings of the fallen officer. On May 16 the conference closes with a Picnic on the Patio night where dinner is provided with games, music and more. This allows survivors to relax and be with each other after a stressful week.

The Fraternal Order of Police and Auxiliary hosts the National Peace Officers' Memorial Service on the west front lawn of the U.S. Capitol on May 15. The surviving family members had an opportunity to place a flower in a wreath honoring their fallen officer.
